



Undo® Mould Remover

Product Description

Undo® **Mould Remover** is a bleach based cleaner designed to remove mould from bathroom and kitchen surfaces. It can also be used on painted surfaces such as walls.

Application Information

Start by removing any loose material from the surface before spraying **Undo® Mould Remover** liberally onto the affected area. Wear protective gloves and avoid spraying near the face. Care should be taken to ensure that **Undo® Mould Remover** does not splash onto household plants or soft furnishings.

Note: **Undo**® **Mould Remover** may discolour coloured bathroom grout. If this is of concern, carry out a test application in a small inconspicuous area and leave for 24 hours before carrying out full treatment.

Undo® Mould Remover should start to work straight away. When using the product around a shower or bath you may want to rinse off when the mould is no longer visible. When used on painted surfaces, use a microfibre cloth to dab the surface to remove excess material.

Precautions

Ensure that there is adequate ventilation when using this product. Open windows during and after use if possible. When using **Undo® Mould Remover** wear protective gloves and avoid spraying near the face.

Avoid contact with metals such as aluminium and stainless steel. Do not use **Undo® Mould Remover** on soft-furnishings. **Undo® Mould Remover** may discolour coloured bathroom grout. When used on sealants some brown discolouration may be present afterwards. Avoid splashing onto household plants.
